FAQ'S

- 1) How long is the walking path? The walking path around the park (not including the pier) is ¾ of a mile
- 2) Can I bring a boat to the park?
- Boats are welcomed at the park, provided they use the finger docks off of the pier and respect the 5 hour time limit. There are 8 slips total 3) Are pets permitted at the park? Leashed pets are welcome at the park. Pet waste must be picked up & disposed of.
- 4) What are the fountain hours? August-May: Wed-Mon, 9:00 AM 7:00 PM ;June& July: 7 days 9:00 AM 8:00 PM
- 5) Is alcohol allowed at the park? Alcoholic beverages are prohibited outside at Indian RiverSide Park.
 - If the dockside pavilion building is rented, alcoholic beverages are permitted inside with proper insurance & licensing.
- 6) What do I do to reserve a pavilion?
 - Call the park office at (772) 692-7501 & check availability for your date & desired pavilion. If available, a fee applies
- 7) Who is responsible for posting the pavilion reservation permit?
- IRSP staff will post pavilion reservation permits in locking cases for paid renters. It is the renters responsibility to bring proof of their reservation with them. 8) What rules apply when reserving a pavilion? *Renting a pavilion reserves the pavilion structure & 10feet of the surrounding area, but does not guarantee use of any open

- The following are prohibited at IRSP Pavilions:

 *DJ's, ponies, water slides etc. *Alcoholic Beverages of any kind *The use of nails and staples
 - *Personal Grills (grilling only allowed at grills provided at Pavilions 3 & 4)
 - *Digging or staking of any kind (tents/shade structures must be stabilized with use of sand bag or other device)
 - * Inflatables of any kind (includes bounce houses)

9) How many pavilion are there & where are they?

IRSP has 4 pavilions at the park:

- Pavilion 1 (east of the fountain) is a first come, first serve pavilion. It has 3 tables, no grill. Personal grills are prohibited
- Pavilion 2 (southeast corner of the building) Rented by permit only for fee. It has 3 tables, no grill. Grills are prohibited.
- Pavilion 3 (southwest corner of the building) is rented by permit only for a fee. It has 2 tables & a charcoal grill.
- Pavilion 4 (northwest corner of the building & west of the fountain) Rented by permit only for fee. It has 2 tables & a grill.
